**Discussion/Action- Minutes of January 15, 2019 meeting**

**Sunset Park Review**

**A. Discussion/action - work to be done in 2019**

**1. New trees – kinds and locations**

Hill had not had time to look for locations for trees due to recent weather.

**2. Rock covers – order for spring installation**

Will Gibson was not present to discuss the rock covers to be ordered.

**3. Update on sign installation – location map**

Hill has given a map to Gibson for the removal and location of the new signs for the park to be installed this spring.

**A. Discussion of work to be done in 2019**

**1. Cut and clear path area's – discussion of proposals for costs**

Hill has the name of three (3) companies that have done work for him in Elm Grove that he can get proposals from to get rid of the buckthorn and restore the area to prairie grass, discussion.

2. Update on sign installation

Park Board members would like the Nature Center sign put up as soon as possible.

**Update on Recreation Department-Dennis Michaelis**

Michaelis stated he has 15 more field rentals, the hardball diamonds are pretty full also, there are three (3) Fire Bird teams this year, he has sent one of the teams to play at Town park. Discussion of possibly enlarging one more of the other softball diamonds at Sunset into a hard ball field. It was felt they should not do that now as all the diamonds are full now.

Meier made motion to adjourn, Jim Gibson seconded, motion carried unanimously. Meeting adjourned at 5:50 p.m.
